

IDIS is the largest manufacturer of South Korean-made video tech. Established in 1997, IDIS offers a range of video solutions to help corporate and public sector organizations keep their people and assets safe and secure across over 50 countries worldwide.

We are headquartered in Gyeonggi-do, South Korea and a trusted technology partner of small to large corporate and public sector organizations worldwide. IDIS has over 600 employees based at its offices and factory in South Korea and regional headquarters in the United States and Europe, with branch sales offices in Dubai, UAE and Ankara, Turkey.

We develop and manufacture our products at the next generation IDIS Smart Factory in South Korea. At the 42nd National Productivity Awards in 2018 (sponsored by the South Korean Ministry of Trade, Industry and Energy) IDIS was honored with a prestigious award for the customized and efficient design of our smart factory that today has a capacity to produce more than 1.4 million products per year.

The IDIS Smart Factory enables us to refine our production processes, reduce wastage and meet continued efficiency targets, while ensuring we adhere to all relevant legal requirements in terms of employee rights and working practices across our entire manufacturing, assembly, and product testing processes, as stated by the South Korean government and in compliance with the UK's Modern Slavery Act 2015.

We continue to review our policies, practices and how we identify any risks of modern slavery and other human rights anywhere within our supply chain. We have a continued commitment to ethical and responsible business practices, ensuring a policy of zero-tolerance to modern slavery anywhere within our supply chain.

As a global company, IDIS works to a set of practices developed to maintain a system of checks and balances to comply with applicable laws and observe the human rights and wellbeing of our people and planet.

Management and control are shared between our senior management team, shareholders, the board and CEO.

IDIS is a public South Korean limited company headquartered in Daejeon. In 2014, IDIS was listed on the Korean Securities Dealers Automated Quotations (KOSDAQ) market. IDIS is governed by the Korea & Futures Exchange Act and rules set out in the KOSDAQ market regulations.

IDIS complies with South Korea's Commercial Code that was developed to encourage transparency of taxation, corporate governance and to improve and supplement shareholder's appraisal rights. IDIS does not diverge from the Commercial Code and our annual report describes how this corporate governance is conducted each financial year.

IDIS is also ISO 9001 accredited which sets out our criteria for quality management. This standard is based on several quality management principles including a strong customer focus, the motivation and implication of our senior management team, our process approach and focus on continual improvement. Using ISO 9001 helps ensure that our customers get consistent, high-quality products and associated technical services, which in turn brings many benefits to our customers and business partners.

We always adhere to legal and regulatory requirements at both global and local levels and seek to be transparent in the way we do business. We believe in open and candid communications with our customers and partners that build trust to ensure mutual success.

## Introduction

At IDIS, we put our priority on protecting your personal information. Acknowledging the importance of your personal information, we strive to secure and carefully process the information you share with us. We value your trust. We hence provide notice regarding how we collect, use, and share your information. Our collection, use and sharing of your information is only based on your permission or were allowed by law. We've taken all the necessary steps to comply with EU General Data Protection Regulation (GDPR).



## **Privacy Policy**

We at IDIS help safeguard your data through technical data security and internal management procedures as well as physical data protection measures. In order to do so, your trust is paramount and thus, we take measures to protect your personal information.

In our <u>Privacy Policy</u>, when we refer to "IDIS", "us", "we" or "our", we mean the IDIS companies which provide you with the IDIS website. The EU General Data
Protection Regulation



The General Data Protection Regulation (GDPR) is a directive under European Union (EU) law regarding data protection and privacy for all individuals within the EU and the way in which that data is processed.

IDIS has embraced GDPR and respects privacy rights globally. Since cyber-attacks and data breaches have become more prevalent, it is no surprise that governments want to hold organizations more accountable.

The responsibility of securely processing and storing video data rests with IDIS customers, making it crucial for them to work with a surveillance manufacturer they can trust and one that will give them the best tools available to support compliance.

IDIS offers surveillance solutions that align with GDPR Article 32 covering the processing of data securely and Article 35 regarding the processing of data within technology. Specifically, IDIS technology helps prevent data theft and allows public and private spaces to stay secure while complying with privacy.

In addition, IDIS Critical Failover also ensures there will never be a gap in customers' footage. Break ins to buildings not only puts physical assets at risk, but digital property that may contain sensitive and personal information. Critical Failover prevents the loss of vital recorded data during an array of fault conditions, ranging from network instability to power supply failure. This means an organization's data protection officer can quickly verify and report any breach no later than the 72 hours as prescribed in GDPR Article 33.

GDPR cites that surveillance footage should only be stored for a length of time that is appropriate to the application. By using the IDIS storage quota functionality, customers can set different retention times for a camera or groups of cameras. For instance, a retail outlet may need to retain footage of financial transactions for a period of 90 days, while for more general areas GDPR recommends a maximum of 30-days.

IDIS technologies such as Privacy Masking and Critical Failover cannot themselves be GDPR compliant.

However, right from the design and development phase, IDIS now considers how products and solutions can assist organizations in deploying and operating GDPR compliant systems.

In addition, IDIS Privacy Masking technology allows customers to mask people in high-traffic areas such as shops or offices as well as areas they want to remain confidential. This feature supports customers when providing video evidence. The way in which IDIS applies this technology means that the original video footage cannot be manipulated or changed. Further, the IDIS proprietary technology, Chained Fingerprint, allows users to detect any sign of tampering or alteration, so users are assured of the integrity of surveillance data itself to provide video evidence that is robust enough to stand up in court.



## The U.S. John S. McCain National Defense Authorization Act (NDAA)

The John S. McCain National Defense Authorization Act (NDAA) for Fiscal Year 2019 was signed into United States of America law on August 13, 2018, and effective from August 2020. The Act establishes a more aggressive stance on U.S. cybersecurity policy, stating that "all instruments of national power" will be used to defend, deter, and respond to significant cyber threats.

The law, specifically Section 889, prohibits federal agencies, their contractors and grant or loan recipients from procuring or using "telecommunications and video surveillance equipment or services" from specific Chinese companies as a "substantial or essential component of any system, or as critical technology as part of any system." The NDAA ban includes telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation, as well as video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company.

Our comprehensive range of NDAA-compliant network cameras, video recorders (NVRs), analytics appliances, and accessories do not use or deploy critical components or System-on-a-Chip (SOC) circuits produced by NDAA banned component vendors, making them compliant with the NDAA. ## Our planet is a community, not a commodity

## Protecting our environment in the way we work

Today, more than ever before, IDIS understands the importance of operating sustainably and playing our part to protect the world around us. It is up to all of us to reduce waste; to use materials and energy with more care; and to remember that today's natural environment is an irreplaceable gift that, once lost, is lost forever. Despite the challenges of the COVID-19 pandemic, IDIS has made headway reducing our TOE (ton of oil equivalent energy consumption) with measures including more efficient use of heating and ventilation in our offices and smart factory.

As we work hard to grow our business, and to share our increasing success with our distribution and integration partners globally, we are also committed to finding new ways to reduce the negative impact of what we do. We must reduce our energy consumption, improve operating efficiency, and remember the harm that waste can do once released into the environment, including plastic and packaging. So, we are striving to continually find new ways to reduce and recycle, and we encourage all our employees and partners to share this vision and to contribute with both ideas and action.



## Reduced manufacturing impact

Our commitment to responsible environmental stewardship has resulted in a series of steps to reduce waste across our Six Sigma led manufacturing processes at the IDIS Smart Factory, which is not a direct user of gas or coal. The IDIS Smart Factory received a presidential citation and National Productivity Award in an awards program sponsored by the South Korean Ministry of Trade, Industry and Energy in 2018 for its process efficiency and zero-waste production processes.

## Efficiencies for 2022 and beyond

The new IDIS factory, due to come online in 2023, is being built to the latest environmental standards and will operate with improved energy efficiency. During 2019-2020 we began to streamline our logistics processes, and achieved efficiencies in the way we re-use and deliver demo kit to our global network of distributors and integration partners. For example, we now bundle deliveries and use international trade shows as a way to supply equipment to our local offices and distribution partners, which serve entire regions, instead of relying on hundreds of separate consignments. This focus on supply chain efficiency will become increasingly important as our business grows.



## Hazardous substances and the environment

In 2006, IDIS became the first digital recorder manufacturer to be compliant with the Restriction of Hazardous Substances (RoHS) Directive. This RoHS certification means that we have eliminated substances in our products that have harmful effects on the environment, pollute landfill sites and are dangerous in terms of occupational exposure during manufacturing and recycling. Today we continue to work diligently to make safer every stage of our product life



## Our renewed commitment to recycling

Our global operations also follow ISO14001 standards to ensure the safe recycling of waste. In addition, under the Waste Electrical and Electronic Equipment (WEEE) Directive, when customers buy new product from IDIS they are entitled to; send old equipment for recycling on a one-for-one, like-for-like basis (this varies depending on the country); send the new equipment back for recycling when this ultimately becomes waste. We have adapted our packaging to make better use of recycled materials. Today our products are boxed and shipped in recyclable cardboard, while our senior executives continue to collaborate with our supply chain partners to research and identify new materials to further lessen the impact of our packaging on the environment.



# Video solutions built to last with energy efficiency at their heart

Through innovative design and engineering our cameras and NVRs are more energy efficient compared with competitive products and help customers reduce their carbon footprint. We continue to strive to make leaps in cutting edge design as we know that even minor improvements can be a force multiplier in reducing energy consumption considering the millions of IDIS products utilized across the world.

A key benefit of IDIS's DirectIP® end-to-end technology is the reduced environmental impact it enables in video applications globally through faster installation and maintenance, meaning fewer engineers on the road. Its hierarchical connection structure and NVRs that come with in-built PoE switches means less cabling and eliminates the need for PoE switches reducing the environmental impact.

IDIS also launched DirectCX® in 2015 to make it possible for customers to use existing coaxial infrastructure, which offers major savings for older buildings and at historical sites through less recycling, the elimination of disruptive civil engineering work, and the implementation of new cabling. IDIS Intelligent Codec also reduces video data and bandwidth requirements by up to 90%, improving wireless transmission of HD video and optimizing storage requirements, which in turn means less electronic equipment and power.

In addition, IDIS offers industry leading warranties on its cameras and recorders, and we ensure that future innovations are backward compatible with existing equipment and software. This is testament to superior South Korean design and development of electronic equipment that is built to last. Our strategy is to extend the lifecycle of our customers' video solutions, reducing the commonplace ripping and replacing of surveillance systems every few years and the constant need to upgrade cameras and other hardware. As businesses adapt to using cleaner energy, IDIS is well positioned to support them to meet reductions in carbon emissions and reduce the burden of future green and eco taxes.
