Europe and Middle East Casino Market Outlook



Traditional hotspots and new destinations



Major new developments—increasingly comprising luxury hotels, state-of-the-art gaming high-end retail, wellness, and leisure facilities—are being sited in traditional tourist hot spots and in up-and-coming destination resorts.

Consumer demand is not the only factor driving growth.

Governments know that successful casino resorts can bring major economic benefits to local communities, generating employment opportunities,

contributing to tax revenues, and stimulating related industries including hospitality and tourism, which in turn supports a wider ecosystem of suppliers.

Forecasts for strong European growth

The European casino gambling market generated a revenue of USD 115.39 billion last year and is expected to register a CAGR of over 5% by 2029, according to analysts. The UK market leads this growth, followed by Italy, Germany, France, and Spain. Other parts of Europe are not far behind thanks to continuing liberalization of gambling regulations, which promises further growth. Europe also tops the table when it comes to the number of gambling properties worldwide. Countries like Romania and Bulgaria, and other countries across the Balkans, are seeing substantial investments in physical casino infrastructure as they reap the benefits of favorable regulations and growing tourism.

Opportunities in the Middle East

The prospect of wider economic benefits, for example, has seen the United Arab Emirates (UAE) moving towards establishing its first casino, marking a significant shift in its traditionally conservative stance on gambling. In September 2023, the government announced the formation of the Gulf Cooperation Council Gaming and Racing Authority (GCGRA), a federal body which will oversee and regulate the gambling industry. Hospitality giants and cruise lines have also expressed interest in operating in the region, the latter for example, using ships that could easily dock in the UAE's growing number of upscale harbor developments.



Understanding Casinos' Risks and Priorities



With subdued lighting and sometimes smoky conditions, chips and cards changing hands rapidly, and crowds gathering at tables, gaming areas have always a focus area for crime. Casinos are prime targets for theft and fraud, both from external criminals and dishonest insiders. Risk factors include substantial amounts of cash on hand, high visitor traffic, wideopen environments with multiple entry and exit points, and the presence of high-value assets throughout the premises.

Criminal Activity

Criminal activity ranges from petty theft, including pickpocketing, to sophisticated scams involving collusion between employees and patrons, and money laundering. Employees with access to sensitive areas and operational information pose a significant risk whether they are conspiring with outsiders or acting on their own.



Cheating at gaming tables is a constant concern, whether it is card counting, using electronic devices, or more traditional methods such as card marking. To maintain the integrity of their games, casinos need to be constantly vigilant.



Video systems deployed in casinos have proved to be highly effective, countering a wide range of threats.

- Casinos need continuous real-time and high-definition surveillance of gaming floors, to allow rapid intervention if operators detect suspicious activity.
- Efficient footage review is vital too, with search tools that enable rapid resolution of disputes and queries.
- Casino resorts typically host VIPs and high rollers, so it is vital that casinos foster customer loyalty through efficient and professional guest services, ensuring minimal disruption to gaming.

For these reasons, casinos have long been among the most enthusiastic users of video technology. Having state-of-the-art surveillance provides reassurance for bona fide customers and acts as a deterrent to criminals and opportunists.

So, there is a willingness in the sector to invest in the best available video infrastructure, if integrators can demonstrate strong business cases.




Building Stronger Business Cases for New Video Systems

In the following pages we cover the essential elements necessary for every casino video system, based on major projects IDIS has delivered with our integration partners in recent years.

Casinos are often complex environments with wide variations in lighting, from subdued, sometimes smoky scenes to bright backlight spaces with windows overlooking panoramic views.

In most casinos it will be important for cameras to deliver both complete scene coverage without blind



spots, and close-up image capture in priority risk locations such as gaming tables, cash desks, slot-machines, bars, entrances and exits.

Wide choice of cameras

It is advantageous to offer a wide choice of high performance cameras with excellent true WDR performance and IR which can cope with all these conditions. Specifying the right camera can save on budgets too. Options can include Fisheyes, which give wide area coverage more affordably than using multiple conventional cameras, and low-profile HD and ultra-HD internal cameras.





For cyber security reassurance cameras should be compliant with local regulations and globally accepted standards such as NDAA. And cameras should come with the assurance of long lifecycle value, extended warranties against failure, and minimal maintenance burden.










Advantages of Better Operating Systems



System Design and Usability is Everything.

For example, surveillance federation services allow for the integration of multiple video surveillance systems across resorts or multiple casinos, giving operators the advantage of multi-task, centralized monitoring, and management. This results in improved efficiency and cost savings. Additionally, a federated architecture enhances security by enabling control rooms to rapidly share video feeds and information across various locations, and to send alerts in the event of threats being detected, facilitating collaboration and response coordination. Furthermore, the service enables scalability and flexibility, allowing expansion of surveillance infrastructure without additional investment.

Well trained teams

Casino security teams are usually well trained and experienced in

operating surveillance systems—and they know what they are looking for—but even for the most confident users there is an advantage in having VMS controls that are more intuitive, easier-to-use, and more comfortable to work with.

For example, smooth 'rubberband' and 'slingshot' controls make pan, tilt, zoom and tracking operations more fluid, helping operators to follow suspect activity without break over extended periods, or to switch quickly from close-up monitoring to wider scene review.

This can make it easier for operators to track suspicious activity in crowded gaming floors.



Mobile apps supporting flexible operations

Apps give authorized managers and pit bosses the option of monitoring, review, and system control via phone and tablet apps. These function as a force-multiplier for busy security teams, supporting greater operational flexibility and maintaining unbroken surveillance while staff are away from the control room.





The Importance of Data Handling, Storage, and The Importance of Data Compliance



A robust video system will ensure that casino's HD and UHD footage is retained for extended periods, without excessive storage costs. With regulations sometimes requiring 30-plus days retention, costs can mount. To prevent this, look for solutions that support H.265 in addition to advanced compression technologies, and that use motion adaptive recording techniques in low activity areas.

Casino video systems should not only comply with local gaming standards, but those increasingly recognized by organizations globally such as NDDA and GDPR; for example, easy-to-use privacy masking is essential to protect the identities of bystanders in the event of security or safety incident.

Popularity of NVR-based systems

NVR-based systems remain popular for casinos as they are highly scalable, allowing for the addition of multiple cameras without the need for extensive cabling or infrastructure upgrades. This makes it easier to expand the system as needed. NVRs also make it easy to integrate with other security and safety systems, such as access control, public address, and intruder systems. This integration enhances overall security and safety and is an affordable route to providing a comprehensive security infrastructure.







Gaining Competitive Advantage With Al-Powered Analytics

In an increasingly competitive market, systems integrators can offer casino operators a competitive advantage:



- Analytics can help managers decide how to place and utilize staff depending on people counting, dwell time, or queues for specific gaming tables or bars.
- Heat maps and flow patterns can distinguish where casino guests spend most time and how they move through the casino, allowing improved floor layouts for enhanced engagement and positive experiences.
- People counting and occupancy monitoring, with analytics targeted at the casino entrances, make it easier to manage peaks and troughs in activity with the right level of staffing thanks to automatic alerts to duty managers.



- Analytics can provide at-a-glance intelligence around seasonal footfall trends, allowing casino managers to analyze visitor numbers more easily against turnover.
- Al video also offers the benefits of metadata search tools allowing for quick and efficient retrieval of specific video footage based on various parameters such as appearance, object type, time, location, and specific events. This can save valuable time and resources when searching for critical information in a large volume of video data.



In addition, video system integration with casino ERP and POS software—with transaction data overlayed on recorded video—allows more efficient incident investigation and wider organizational benefits.




Phased approach to adoption
